How to do the right thing, the wrong way. Amnon Zohar – my own opinion, April 3<sup>rd</sup>, 2003

Like it or not the war is on. Rightly or wrongly it is in the best interest of all involved that the war will be short and decisive. The victory is not really in doubt and therefore the United States and the world at large need to get beyond the Sadam regime and begin to assess the awful damage that has been done to our globe as a result of doing the right thing the wrong way.

There is no other way, as there remains no power in the world to force a cessation of hostilities and rescue Sadam 's regime. Sadam's popularity in the global environment is at an all time low and it would be very easy to generate a consensus of world opinion that the gig is up on Sadam. In fact that consensus actually exists, even today, even in the middle of the war that the world totally rejects as a means to achieve an otherwise desired outcome. So what went so terribly wrong?

Justifying the first U.S led pre-emptive war is a tough sell to the American people and to a wide range of political constituencies. So there comes out the oldest sales trick in the book. As they say in Texas: "Let's throw some stuff on the wall and see if any of it sticks". We must disarm Sadam of Weapons of Mass Destruction, now, or face immediate and present danger. We are the leaders of the free world and it is our obligation to protect democratic values and liberate the Iraqi people from oppression. We cannot stand idle in the face of human rights violation.
